GROW YOUR EXPORT BUSINESS BY LEVERAGING STEP VOUCHERS

The STEP Grant voucher program has allowed Silicon Forest Electronics to play on the world stage of aviation. The grant created an affordable opportunity for a small company to participate in the Farnborough Air Show and the Paris Air Show. Neither would have been feasible without the STEP Grant support. As a result, we created an international marketing and sales presence. Our international business has increased from zero to five percent of our total revenues with many more prospects in the wings.

State Trade Expansion Program (STEP)

The Washington State Department of Commerce is awarded another STEP grant to help small businesses in exporting. This is the ninth consecutive year of funding. More than 900 unique businesses around the state have benefited from STEP-funded support. Combined, they have achieved more than \$750 million in export sales.

STEP Vouchers Available to Reimburse Export Related Expenses

Qualifying Export Expenses:

- Design of international marketing, digital advertising (voucher reimbursement up to \$6000)
- International website design, development and translation
- International search engine optimization, maintenance and monitoring; website localization
- Expenses to set up a website to accept international payments
- E-commerce fees including hosting and maintenance (voucher reimbursement up to \$6,000)
- Translation of marketing media, including audio/video (voucher reimbursement up to \$6000)
- Online market listing fees (voucher reimbursement up to \$6,000)
- International shipment of product samples (voucher reimbursement up to \$4,000)

- Services of the U.S. Commercial Service
- Compliance testing of an existing product for entry into an export market (voucher reimbursement up to \$6,000)
- Export research tool subscription (voucher reimbursement up to \$2,000)
- Cost associated with international IP protection limited to USPTO PCT transmittal fees up to \$120, filing fees up to \$200, search fees up to \$1040, Hague Intl Design App transmittal fees up to \$60, Trademark Madrid Protocol fees up to \$250
- International business travel (airfare only, economy rate only)
- International trade show or mission fees (virtual or in-person)
- International conference or symposium fees

Eligibility

- Be registered to do business in Washington.
- Have a Federal Employer Identification Number tied to a Washington address.
- Be in good standing with the Washington State Department of Revenue.
- Be a small business concern (SBC) as defined by SBA criteria and meet other program criteria, such as being in business for at least one year and being able to demonstrate export readiness.
- Have at least 51% of your total goods/services sourced from the U.S.

Apply

- Visit bit.ly/export-vouchers and download and complete the application.
- Applicants must demonstrate export readiness, financial resources and commitment necessary for exporting, and the value of the proposed export activity in their application.
- Keep all your receipts for preapproved eligible expenses and make sure you meet all the required criteria to receive reimbursement.
- Voucher awards require a cash match of 25% of the voucher value.
- Export activities must be completed by September 30, 2021 or when the STEP fund runs out, whichever comes first.
